In order to fulfill the provision of Article 43B Financial Services Authority Regulation Number 14/POJK.04/2019 regarding Amendments of Financial Services Authority Regulation Number 32/POJK.04/2015 regarding Capital Increase with Pre-emptive Rights ("**POJK 14/2019**"), Indonesia Stock Exchange Regulation No. I-A regarding Listing of Shares and Equity Other than Shares Issued by the Listed Company, and Decree of the Board of Directors of the Indonesia Stock Exchange Number Kep-00183/BEI/12-2018 on 26 December 2018, the Directors of PT Buana Lintas Lautan Tbk. ("**the Company**") hereby inform the Shareholders that the Company has carried out the Capital Increase without Pre-emptive Rights ("**NPR**") with result as follows:

The total number of issued and paid-up shares of the Company before the implementation of the NPR was 14,085,851,449 (fourteen billion eighty-five million eight hundred fifty-one thousand four hundred forty-nine) shares, and the number of shares resulting from the implementation of the NPR was 1,408,585,144 (one billion four hundred eight million five hundred eighty-five thousand one hundred forty-four) shares. Accordingly, the total number of issued and paid-up shares of the
